ORDER

Vide paper (1) read above, V N Public Health and Educational Trust submitted application for starting new Medical College named, "Palakkad Institute of Medical Sciences" with an intake of 150 MBBS seats for the academic year 2020-21 at Walayar, Palakkad.

Vide paper (2&3) read above, in accordance with clause 2(5)(ix)(11)(ii) of the Amendment of the 1st Statute on the matter of affiliation of colleges and clause I(1) of the Inspection Ordinance on the matter of Affiliation of new Colleges, University conducted legal scrutiny and inspection in the said college.

Vide paper (4&5) read above, upon the verification of the inspection report the scrutiny committee pointed out gross deficiencies. The same was intimated to the college. Subsequently, the college has submitted the compliance report.

On verification of the compliance report it was noted that the deficiencies were not rectified by the college. Therefore University rejected the application for starting MBBS course.

Vide paper (6) read above, V. N Public Trust filed an Special Leave Petition before Hon'ble Supreme Court of India and Hon'ble Supreme Court had directed University to consider the application for Consent of Affiliation for starting MBBS course of the said college .

Vide paper (7) read above, in compliance with the said judgement, University conducted inspection in Palakkad Institute of Medical Sciences for the starting of new Medical College with an intake of 150 MBBS seats for the academic year 2023-24.

Vide paper (8) read above, the Inspection report was scrutinized by the Scrutiny Committee and recommended to grant consent of Affiliation .

Accordingly, University issued Consent of Affiliation to Palakkad Institute of Medical Sciences for starting MBBS course with an intake of 150 seats for the academic year 2023-24, vide paper (9) read above.

Vide paper read (10) above, on receipt of Letter of Permission from National Medical Commission the Principal, Palakkad Institute of Medical Sciences had submitted application for Provisional affiliation for starting MBBS course with an intake of 150 seats for the academic year 2024-25.

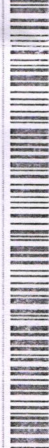
Vide paper (11&12) read above, University conducted final inspection in Palakkad Institute of Medical Sciences and the inspection report was scrutinized by the Scrutiny Committee and reported deficiencies as per Minimum Standard Requirements 2023.

The deficiencies were intimated to the college and informed to submit the compliance report.

In meantime , Hon'ble High Court of Kerala directed University to consider the application for provisional affiliation of the petitioner college by applying the Minimum Standard Requirements that was applicable for the academic year 2023-24 vide paper (13) read above.

Vide paper (14) read above, in compliance with the order of Hon'ble High Court of Kerala, the matter of granting Provisional Affiliation to Palakkad Institute of Medical Sciences starting of MBBS course for the academic year 2024-25 was placed before the Sub Committee of the Governing Council and the Committee recommended to grant Provisional Affiliation for MBBS course with an intake of 150 seats.

Since the name of the Medical Colleges had to be forwarded to CEE and DME urgently for the allotment , based on the recommendation of the Subcommittee of Governing Council, Hon'ble Vice Chancellor granted Provisional

Affiliation to Palakkad Institute of Medical Sciences for the starting of MBBS course with an intake of 150 seats for the Academic Year 2024-25 subject to the ratification of Governing Council. Accordingly, University forwarded the name of the college to CEE and DME for considering this college in the allotment process for the academic year 2024-25.

The college has remitted requisite amount of Affiliation fee and Refundable Deposit.

In the circumstances, orders are hereby issued granting Provisional Affiliation to Palakkad Institute of Medical Sciences for starting of MBBS course with an intake of 150 seats for the academic year 2024-25, subject to ratification of Governing Council.

In addition to the above, the college shall satisfy the conditions detailed below:

(a) Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

(b) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

(c) Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

(d) Admission to the next academic year shall be done only after obtaining prior permission from the University. The College should collect fees (one-time payment at the time of admission) from the students to be remitted to the University as follows:

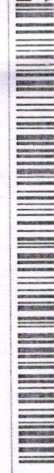


