### **ORDER**

Vide paper read (1) above, the University had invited applications from the affiliated colleges for granting Continuation of Provisional Affiliation for the academic year 2025-26.

In response to the above notification, the Principal, Palakkad Institute of Medical Sciences, Walayar submitted applications for the Continuation of Provisional Affiliation for the academic year 2025-26, vide paper read (2) above.

University had posted inspection in connection with Continuation of Provisional affiliation for the academic year 2025-26 and the inspection team submitted the inspection report after conducting the inspection, vide paper read (3) above.

After scrutinizing the inspection report, the Scrutiny Committee did not recommend granting Continuation of Provisional Affiliation for the academic year 2025–26, vide paper (4) above.

The same was intimated to the college, vide paper read (5) above. Subsequently, the college submitted the compliance report, vide paper read (6) above.

Vide paper read (7) above, National Medical Commission (Under Graduate Medical Education Board) decided to reduce 50 MBBS seats (150 to 100), and granted conditional renewal for 100 MBBS seats for the academic year 2025e-mail: keralahealthuniversity@gmail.com Phone: 0487-2207664, 2207642 Fax:: 0487 - 2207616, 2207620

Based on the renewal order and compliance report, the Dean, Faculty of Medicine, recommended granting Conditional Continuation of Provisional Affiliation for the MBBS course with an intake of 100 seats for the academic year 2025–26, subject to the declaration received from the Principal & Chairman, Palakkad Institute of Medical Sciences, Walayar, regarding rectification of deficiencies, vide paper read (8) above.

Accordingly, Principal & Chairman, Palakkad Institute of Medical Sciences, Walayar submitted an undertaking stating that all the deficiencies pointed out during the inspection of Palakkad Institute of Medical Sciences, Walayar would be rectified before the admission, vide paper read (9) above.

Since the details of the courses had to be forwarded to CEE and DME urgently for the allotment of UG, PG and Super Speciality seats, based on the undertaking submitted by the college, Hon'ble Vice Chancellor granted Conditional Continuation of Provisional Affiliation to MBBS Course with an intake of 100 seats for the Academic Year 2025-26 subject to ratification of Governing Council.

Accordingly, University forwarded the details of the courses to CEE and DME for considering this college in the allotment process of UG course for the academic year 2025-26.

The 85<sup>th</sup> Governing Council has resolved to ratify the action of the Hon'ble Vice Chancellor in having granted Conditional Continuation of Provisional Affiliation to Palakkad Institute of Medical Sciences, Walayar for conducting the MBBS course with an intake of 100 seats for the AY 2025-26 and forwarding the same to DME/CEE, vide paper read (9) above.

Accordingly, orders are issued ratifying the action in having granted Conditional Continuation of Provisional Affiliation to Palakkad Institute of Medical Sciences, Walayar for conducting medical UG course during the academic year 2025-26 subject to the following conditions.

- 1. University reserves the right to conduct surprise inspection at any point of time and to take appropriate action accordingly.
- **2.** It shall be the duty of the Institution to rectify all the deficiencies pointed out by the university as stated in the undertaking submitted by the Principal & Chairman, Palakkad Institute of Medical Sciences, Walayar.

As per the clause 2 (5) (ix) (16) of the Amendment of the I<sup>st</sup> Statute on the matter of Affiliation of Colleges, 'if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfillment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation shall cease automatically. If the conditions are fulfilled, the Governing Council shall have the power to confirm the affiliation at the end of the period '.

In addition to the above, the college shall strictly adhere to the conditions detailed below:-

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Hon'ble Supreme Court of India in writ petition (C) No.656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The colleges have to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with copy of the letter of approval from apex bodies concerned.
- The colleges should remit annual administration fees fixed for UG / PG courses for the academic year 2025-26, if applicable.
- The College shall produce the orders regarding the constitution of College Council for the academic year 2025- 26 during the time of student data verification.



• Admission to the next academic year shall be made only after obtaining prior permission from the University.
